ReFissa does not eliminate wrinkles, repair sun-damaged skin, reverse photo aging, or restore more youthful or younger skin. Do not prescribe if the patient uses drugs known to be photosensitizers, is pregnant, attempting pregnancy, or nursing. In some cases, ReFissa may cause redness, itching, burning, stinging, and peeling. The patient should be advised to decrease medication and frequency of application. If irritation persists, discontinue use.

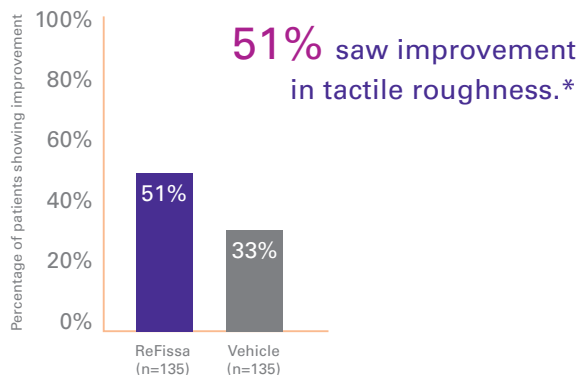
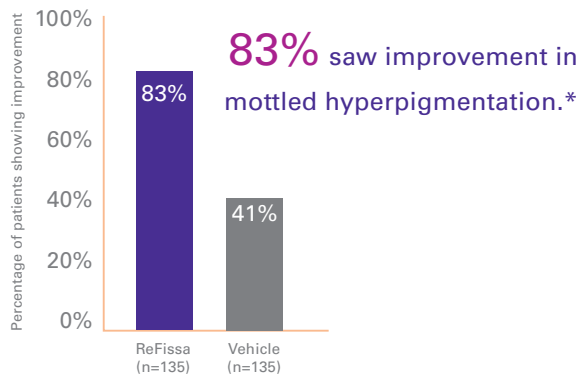
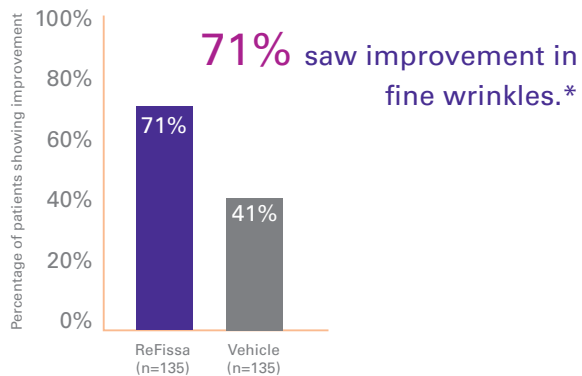
